

ORDINANCE NO. 398

**AN ORDINANCE AMENDING SECTIONS OF CHAPTER 2 IN THE HANNA MUNICIPAL CODE BOOK IN THE FOLLOWING CHAPTERS: AMEND CHAPTER 2.03, SECTION 02.03.010, OMITTING CHAPTER 2.04, PLANNING COMMISSION, OMITTING CHAPTER 2.16 PARKS AND RECREATION BOARD, OMITTING CHAPTER 2.18 CEMETERY BOARD, OMITTING CHAPTER 2.19 VOLUNTEER FIRE DEPARTMENT, AMENDING CHAPTER 2.22 SECTION 2.22.010 POSTING PLACES.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF HANNA, WYOMING:**

**Section 3.** Severability. If any section, subsection, sentence, clause, phrase, or portion of this ordinance (or application thereof to any person, entity, or circumstance) is for any reason held invalid by any court of competent jurisdiction, such portion shall be deemed a separate provision, shall be stricken here from, and shall not affect the validity of the remaining portions of the ordinance.
